The following items have been added to clarify the existing Specifications for the Tennis Center Roof and Gutter Repair Work.

- 1.) Base Bid Work shall include the complete seaming of all standing seams roof panels utilizing the "Single Lock Seam" for all areas.
- 2.) Alternate 1: Gutters and Downspouts: All gutters and downspouts shall match the existing Tennis Center roof color. Gutters installed shall be fabricated to replicate the existing gutters by utilizing the same aluminum gauge and matching the existing gutter profile. All existing and new gutters shall have all seams and end caps sealed and must be leak free guarantee for 1 year.
- 3.) Alternate 2: Limestone Coping Metal Cap: Contractor shall install a high quality ice and water shield membrane before installing the metal cap on limestone coping.
- 4. A warranty of all areas of repair shall be provided by the contractor, including, but not limited to, areas immediately adjacent to such areas of repair. Contractor shall document all areas of repair with specificity and photographs.
